Welcome to the MedSafe Compliance Veteran Grant

Please read the following Qualifications and Terms carefully. By submitting your application you agree to all terms.

1. Must be a citizen of the United States
2. Be an honorably discharge veteran, or the spouse of a deceased or disabled veteran (document DD214)
3. Have a clean background check. Submit social security number for a background check/ credit check
4. Devote at least 30 hours a week to the business
5. Be willing and able to enter into and sign a Franchise Agreement
6. Be willing and able to attend a training within 3 months of acceptance
7. Have basic office capability (phone, fax, internet access, computer with all Office suite programs)
8. Have a valid current driver's license and dependable/professional transportation that meets the approval of MedSafe Compliance
9. Have living expenses covered while developing the business
10. Agree to allow your imaged to be used in all advertising, PR and internet marketing

*This offer is valid providing territory is open where winner lives. If territory where you live is not available, you may apply for the next closest territory.

1. THE GRANT

MedSafe Compliance: The grant application period will open on September 1, 2019 and continue until December 31, 2019. A franchise territory up to 100,000 populants will be awarded. This license, apparel and training will be included at no cost to the applicant. Recipient will be subject to all terms and conditions of the standard MedSafe Compliance Franchise Agreement once they own the license. If applicant wants to consider a larger territory purchase for that area must be outside of this grant. The standard minimum value for this award would be in excess of \$25,000.00

2. ELIGIBILITY

Veteran: The winner must provide a copy of their honorable discharge papers or pending separation expectation date. See other requirements above.

For all grant applications: No purchase is necessary. The Grant is open to any honorably discharged veteran (or the spouse of deceased or disabled veterans) from

any of the US Armed Forces. The applicant must be a legal resident of the United States and must remain so during the ownership of MedSafe Compliance unit franchise. Employees of MedSafe Compliance or Total Compliance Solutions, Inc., managers and officers and their immediate family members (parent, child, sibling, spouse), and persons living in the same household of each such person (Whether related or not) are not eligible. Void where prohibited.

3. HOW TO ENTER AND HOW TO WIN

You can apply by completing the application on this website. You can upload a scanned or photocopy of the required paperwork listed above pertaining to a status and supporting application details. If chosen a finalist additional information or paper work may be requested. We reserve the right to verify any information stated in the application. Finalist will be issued full FDD and Franchise Agreement to review and make any additional material to their application. All applicants may contact MedSafe Compliance, LLC for the FDD and franchise agreement details. The winning applicant will be determined from the finalists within 90 days after the close of the application period. Face to face interviews may be requested at any time during the selection process. MedSafe Compliance reserves the right not to award the grant if none of the applicants are determined to be qualified.

4. NOTIFICATION

Prizewinners will be notified by phone, by email or in writing following selection.

Non-Winners: Any qualified applicant that is not chosen as a Franchise Grant Recipient Winner or Finalist may not be personally contacted. Applicants still have the option to pursue the purchase of a MedSafe Compliance Unit Franchise.

5. TERRITORY
